Tournament Rules

- All participants must have an active membership through the Central Sonoma County USBC (CSCUSBC). Any participants who have memberships outside of CSCUSBC can pay a \$8 local fee to become members of CSCUSBC.
- 2) Choice of squad times shall be given according to the order which entries are received by the Tournament Manager.
- 3) Handicap will be calculated as follows:
 - a) Singles 90% of 240.
 - b) Doubles 90% of the difference between the doubles average and 480.
 - c) Team 90% of the difference between the team average and 960.
- 4) **TEAM** any 4 bowlers. Team event may be bowled multiple times, with at least 2 different bowlers changed in the lineup. The first team appearance counts toward the All-Events total. No partial teams accepted.
- 5) **DOUBLES/SINGLES** any 2 bowlers. D/S event may be bowled multiple times, but must have a different partner each time. The first appearance in the D/S events counts toward the All-Events total.
- 6) Bowlers may cash only once in All-Events.
- 7) Competition will consist of 3 games in each event. Doubles and singles will be bowled on the same pair of lanes.
- 8) **ENTERING AVERAGES** each bowler's entering average will be based on the highest of the following averages, in the following order:
 - a) USBC certified average (minimum of 21 games) for the 2018-2019 winter season OR USBC certified average (minimum of 21 games) as of January 1, 2020.
 - b) USBC certified averaged (minimum of 21 games) for the 2018-2019 summer season.
 - c) If none of the above apply, the bowler will use an average of 240.
 - d) If a sport or challenge condition league average is the bowler's only verifiable average, it will be adjusted per the appropriate USBC conversion chart to determine the correct entering average.
- 9) No fees will be refunded. There will be a \$25 charge for returned checks.
- DRESS CODE dress appropriately for a Championship tournament. No sexual, profane, or otherwise offensive material will be allowed on any attire or equipment. No tank tops or cut-offs allowed. Tournament management shall determine the validity of any complaints.
- 11) Unsportsmanlike or disruptive behavior will not be tolerated. Improper conduct, as determined by the tournament management, may result in disqualification and cause you to forfeit your entry fee and all prize money.
- 12) The use of EZ Slide or any other such substance applied to the sole of the shoe is not allowed.
- 13) Except as altered above, all other USBC rules apply.
